## I. Introduction/Overview/Philosophy

AP Studio Art is a full-year weighted course that sets the national standard for performance in visual arts and allows students to pursue college level work through the development of a portfolio in the drawing category as held by the AP College Board. The students will develop mastery in concept, composition and execution of ideas through a three-part portfolio. The work is evaluated based on the components of Quality, Breadth, and Concentration which are reviewed at the AP level. Individual artwork will be measured by quality, depth, discovery, and superior knowledge of art principles and techniques. Students are responsible for demonstrating advanced knowledge of the elements of art and principles of design through any two-dimensional medium or process. Students are expected to explore ideas using an ongoing process of experiments, practice and planning.

## II. Objectives

#### Course Outline:

- A. Comprehensive Portfolio Introduction
  - a. Summer A selection of projects based on National AP standards and a selection of current college portfolio requirements to be completed before the course begins.
  - b. 3 Section Portfolio Overview
    - 1. Breadth, Concentration, Quality: overview of expectations within each portion of the portfolio, and expected performance. Each portion is equally weighted by the college board although level of expertise may vary amongst sections.
  - c. Personal Investigation of Works identification and exploration of media and content in correlation with the students overarching goals for their work
    - 1. Plagiarism: what's fair use, what's copyright infringement, and how to push and maintain originality in the work.
- B. Breadth Portfolio
  - a. First portion of the course, where students will demonstrate understanding of drawing through application of techniques and styles for a total of 12 works. Demonstration of fully resolved subject matter such as, but not limited to, landscapes, objects, faces, places, figures.
- C. Concentration Portfolio
  - a. Second portion of the course, focused on an in-depth exploration of a particular drawing concern. The concentration is centered on a theme that is explored throughout 12 separate works.
- D. Quality Portfolio
  - a. A selection of five pieces of artwork created during the course, prepared for presentation and mailed directly to the AP College Board.
- E. Preparation and Submission
  - a. A digital portfolio is prepared through the AP digital submissions host website.
  - b. All works are labeled with size and medium. Concentration statements prepared and submitted.
- F. Website
  - a. Students develop a portfolio website to showcase work.

# AP Studio Art VI. Articulation/Scope & Sequence/Time Frame

AP Studio Art is a one-year elective course.

The Art Department courses are the building blocks for the AP Studio Art elective. It is expected that the prospective AP student will have taken many to most of these offerings.
